- 4. Treasurer's report: Linda Stolt
  - A. All deposits have been made. Payments will go out next week.

    All bills have been paid. We have lots of transfers this time of the year.
  - B. There are stragglers who have not paid their membership dues yet.
- 5. Society Business: Joan Gazdic
  - A. We have 79 active members and a total of 89 members.
  - B. Our collegiate scholarships are \$2000 for the recipient's freshmen year of college. We extend it to \$300 per year for the sophomore, junior, and senior years. This should cover their books and fees.
  - C. We support our state organization by donating to Women in the Arts with our memorials.
  - D. The state organization receives a portion of all our membership dues.
  - E. The final budget for the year 2023-2024 was presented.
  - F. If your committee has suggestions for any rule changes please let Joan know. Bring them to the March meeting. They will be discussed by the Rules committee. Membership will vote on them at the May meeting.

- C. We will have the wine pull at the Holiday Auction again this year. We will also raffle off self-care items.
- D. We started a marketing team to help publicize our scholarships in hopes of getting more applicants.
